# **Hungary: Key Asylum Figures as of 1 July 2016**

#### How many?

Despite the construction of the border fence on the Serbian and Croatian border sections, the number of **irregular migrants** apprehended by the Hungarian police has been constantly **on the rise** since the beginning of 2016:

The same trend could be observed with regard to the number of asylum claims registered in Hungary:

In the first four months of the year, only **228** asylum-seekers were **granted protection** (refugee status or "subsidiary protection" status).

### From where?

During the first six months of 2016 the majority of asylum-seekers (**65%**) **came from war- and terror-torn countries**, including 15% from Syria, 37% from Afghanistan, 11% from Iraq and 1% from Somalia.

#### Where are they?

Based on the information provided to the HHC by UNHCR, on 20 June, **1 489** asylum-seekers were accommodated at **open reception centres** (in Bicske, Vámosszabadi, Körmend and Balassagyarmat).

On 20 June, **734** first-time asylum-seekers were **detained in specific "asylum jails"** (in Békéscsaba, Kiskunhalas and Nyírbátor).

#### **Dublin returns**

In the first five months of the year only **300** asylum-seekers were **sent back to Hungary** under a so-called Dublin procedure, primarily from Germany (144) and Switzerland (44).

#### Returns to Serbia

In the first five months of the year only **99** irregular migrants were officially **returned to Serbia** (note that the refusal of the asylum applications in the transit zones do not result in such official transfers). This includes 33 Serbian, 26 Kosovar and 19 Albanian citizens. None of the returnees were Syrian, Afghan, Iraqi or Somalian citizens.

### Criminalisation of irregular border-crossing

Between 15 September 2015 and 26 June 2016, **2 839** persons were **tried at court** out of which 2 792 were convicted for the "prohibited crossing of the border closure", namely the border fence between Serbia and Hungary.
