Police remember the guy in the green shirt who only spoke Arabic and #AhmedH who was speaking EN. He says #AhmedH tried to calm them down!

Police: They gesticulated heavily and for someone who did not understand what they said it might seemed scary.

Police: defendant wore a red shirt. #AhmedH: I did not. Police: Maybe not, I do not remember exactly. Just to have a sense about the process

The guy who was shouting was around 35- 40, bearded and had brown skin. He was 180-190, normal weight. And that's all the police remembered.

The megaphone was taken from him by an Afghani or Pakistaniman. I did not want to throw towards the police.

[#AhmedH](#) admits that he threw sg but he does not know what. He was angry and upset.

[#AhmedH](#) to the people: be calm, sit down and show a positive image to the police, they might let us in.

He denies that he said "we will get through at any price" or giving ultimatum to the police.

On using the megaphone: I only remember that I did not demand or said anything offensive/ threatening.
